**Promotion:**

The following **Inspectors of Income-tax** are hereby appointed on promotion as **Income-tax Officer** in the Pay Level 8 (Pre-revised Pay Band Rs.9300 – 34800/- with Grade Pay Rs.4800/-) purely on **Ad-hoc** basis with effect from the date of their joining on such promotion and for a period of one year or until further orders whichever is earlier.

The seniority List of the fedre grade (Inspector), as on date is sub judice in various cases pending before the CAT Kolkata bench, Kolkata on the issue of date of effect of the NR Parmar judgement of the apex court delivered on 27.11.2012. The above persons are being allowed ad-hoc promotion as they are senior most and at the top of both the seniority list (Pre N.R Parmar and Post N R Parmar) of the feeder grade (Inspector).

**2. Posting:** On promotion, the officials will continue to discharge their functions and duties on *in situ* basis at their respective present office(s), until further orders.

**3.** The Adhoc promotions are subject to the following conditions:

- The Adhoc promotion shall not confer on the officials concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;
- The officials are liable to be reverted at any time without assigning any reason.
- The promotion is valid for one year or till their reversion to the feeder cadre or regularisation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.
- The officials are not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. They will be entitled to exercise the option on the regularization against regular vacancy.

**4.** The continuation of above ad-hoc promotion is further subject to :

a. Final outcome of SLP(C) 30621 of 2011, Jarnail Singh and others vs Lachmi Narain Gupta and others, still pending before the Supreme court of India.

b. Any instruction / clarification of DOPT regarding interpretation/ implementation of the judgement of the supreme court of India in CA.No 8833-8835of 2019, K. Meghachandra Singh & Ors Vs. Ningam Siro & Ors.

c. Clarification on order dated 21.11.2019 in the OA No.350/01530 of 2019, in the case of Satyabrata Pramancik Vs UOI & Others, being sought from Central Administrative Tribunal, Kolkata.

d. Implementation of any instructions/guidelines which may be issued by CBDT/HRD in compliance to the judgement delivered by the Hon'ble Supreme Court in the case of Pratibha Rani & Ors. Versus Union of India & Ors.

e. Any other order/judicial pronouncement on these issues.

5. The officials who have been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, in the same grade pay/pay level, will not be eligible for any further pay fixation now.
6. The officer concerned is directed to join his new assignment on or before 18.08.2021. If, however he is unwilling to accept such promotion, an intimation that regard shall be sent to the office of the undersigned on or before 23.08.2021.
7. Postings on promotion mentioned in this order is purely temporary and the officer is liable to be transferred within West Bengal Region in future.
