Sub: Regarding Services under Project TARANG.

Ref: BSNL CO Letter No. 3-32/2011(Pt.)/EB-I/20 dated 12/6/2018

Please find enclosed above referred letter vide which approval of following enhancement in services to Income Tax Deptt. (ITD) under Project 'TARANG' has been conveyed by BSNL CO:

- i. Total 10,000 nos. additional Mobile SIMs/Landline/Broadband connections to be provided to ITD in lieu of surrendered 1,000 nos. Blackberry & 8,000 nos. data cards. Landline-with Broadband to be counted as 2 separate nos. of connections.
- ii. The speed of Broadband connections be enhanced from existing 512 Kbps to 8 Mbps speed till 35 GB download per month and downgraded to 1 Mbps beyond 35 GB.
Upgradation of BB Bandwidth to 8 Mbps is subject to availability of media (OFC). Otherwise, BB bandwidth may be upgraded to max possible bandwidth upto 8 Mbps which may be supported by existing media.
- iii. On all Mobile SIMs under Project 'TARANG' in place of 1 GB per month, 2 GB per day is allowed.
- iv. 500 free SMS per month to other telecom service provider.
- v. Unlimited calls to other operators at home circle as well as free outgoing in roaming.

Therefore, it is requested to implement the necessary changes in billing system towards existing charging plan of Project "TARANG".
