Respected Sir,

Sub :- Revival of the agitation since suspended in support of important pending demands - Intimation regarding -

Your kind attention is drawn to our communication dated 31st July 2018, vide which it was conveyed that the suspension of the above stated agitation programme would continue till 18th August .2018, purely on the basis of the assurances received from your end as well as from the then Member(Admn), CBDT. Following your direction, we pursued the issues with the concerned authorities on regular basis and met the newly appointed Member (Admn.) on almost every alternate working day. We have relied on the assurances given by the concerned authorities as well as the Member (Admn.), so much so that we have extended the suspension of agitation beyond the date communicated to the Board, waiting for the positive outcome.

Now we are appalled to observe that even the direction and the assurances from the highest level of the organization have failed to yield any fruitful result in case of almost all of the pending issues of the charter of demands. Whatever little progress taken place is clearly detrimental to the interest of the employees.

You have pointed out during several occasions in the recent past that there is no need to hold the formal meetings with the JCA like PGRC or QRM, as you always accommodate us to discuss any issue even during your busiest hours. We are grateful for such kind and employee friendly gestures. But meetings and assurances mean nothing to us, unless they are followed by delivery. You will appreciate that we are all here to resolve the genuine grievances of our members and not to keep you or the authorities below busy in meeting us. We would like to inform you with deep regret that inspite of our consistent persuasion with the Member (Admin) almost on daily basis and repeated assurances given to us by the Member (Admin) on every such occasion of our meeting with him, nothing significant has so far been done in respect of our grievances.


The Central JCA has taken stock of the situation and minutely examined the development (though nil or rather negative) in respect of the pending issues. In the above scenario, **the Central JCA is compelled to decide that the members of Central JCA will not participate any Survey including TDS Survey/Spot Verification and Search & Seizure operation from 1st December 2018, unless the following pending issues are resolved immediately:**

- 1) Constitution of the Cadre Review Committee.
- 2) Recruitment Rules of EA and ITI may be put on hold till the next Cadre Review as per discussion held with the then Member(Admin), CBDT with the JCA.
- 3) Relaxation for promotion to the posts of TA/Sr.TA/Steno Gr.II (erstwhile) in existing RR due to huge vacancies in promotion quota and change of crucial date of eligibility from 1st April to 1st January as Per DoPT's Order.
- 4) Regularisation of 2014-15 batch of promote ad-hoc ACIT and their timely promotion DCIT w.e.f 01.01.2019 including the left over officers of 2013 and earlier batches.
- 5) Grant pay parity of Inspector & ITO with the IB/CBI and upgradation of pay of Tax Assistant to Rs.2800 as per CSS/Organized Accounts Service through Departmental Anomaly Committee.

We, therefore, request your goodself to kindly ensure that the assurances given so far are translated into the desired result by this month end.
