Subject: Constitution of CBDT Sports and Cultural Committee –Reg.

To complement the efforts of the Central Revenue Sports Board, it has been decided to constitute a “CBDT Sports and Cultural Committee”, to provide a framework for better management of sports and cultural activities within the Income Tax Department. The committee will be constituted with the following mandate:

1. Organizing intradepartmental sports activities
2. For monitoring effective budgeting and utilization of the funds allocated under the head ‘contributions’ for sports and cultural activities
3. For strategic planning of sports recruitment, in coordination with Cadre Controlling Pr. CCITs, to help set up regional & national Income Tax teams.
4. For the organization of Intra departmental cultural activities for the selection of representative participants from the Income-tax department in various cultural events/competitions
5. To set up sub-committees for various disciplines and activities, for the furtherance of its objectives

The Chairman CBDT would be the Chief Patron and Member (Admn.), CBDT would be the Patron of the CBDT Sports and Cultural Committee.

The committee may co-opt at least one staff member and one officer, who are members of the staff/officer's association as members of the committee.


The secretarial assistance to the committee would be provided by the Directorate of HRD, CBDT.

Regional Sports & Cultural Committees, with the same mandate at the regional level, may be formed at the headquarters of the Cadre Controlling Pr. Chief Commissioners & headed by either the Cadre Controlling Pr. Chief Commissioner, or some other Chief Commissioner nominated by him for this purpose, with the Additional CIT(Hqrs)(Admn.) O/o CCIT(CCA) as the ex-officio secretary. The Pr. Chief Commissioner CCA may nominate such people who have an interest in the organization of sports and cultural activities to

this committee. The Committee may also have some representation from the staff and the officer's association.

All Cadre Controlling Pr. Chief Commissioners/Director Generals may kindly take necessary steps to constitute the Regional Sports and Cultural Committees at the earliest any may inform the details thereof to the Directorate of HRD.
