Sub: High handedness of Pr.DGIT(NADT), Nagpur

This has with reference to the above mentioned subject.

We would like to bring to your kind notice that one meeting was organized, though informal in nature, on 13-06-2016 at 6.30PM by the newly promoted ACsIT who are undergoing training in the NADT, Nagpur at present and the Secretary General, ITGOA was invited to address the meeting and appraise the members of various issues including the regularization of the ACIT promotion of the 2014-15 batch. For the purpose, the Secretary General, ITGOA visited Nagpur on 13-06-2016 and our members at NADT proposed to hold the event in an open-air meeting place and that too after the day's training schedule was over. The Secretary General was supposed to address the meeting and discuss the issues. But the NADT, Nagpur authority denied to accord permission for any such meeting and/or discussion of the trainee members with the leaders of ITGOA inside the NADT Campus on the plea that ITGOA is a political entity and the leaders of ITGOA were denied entry into the campus for holding the meeting. Though it was categorically explained that the purpose of the said meeting was nothing but to appraise our members about the status of some of the burning issues relating to their career prospect in the Department and to discuss the same, the NADT authority showed its utmost apathy to listen to it. The members of ITGOA were forced to hold the meeting in the main road outside the NADT campus.

This a disgrace to a service association recognized by the Govt. of India and also to the membership of entire Gr. B & Gr. A officers of the Department. The ignorance of the purpose of a recognized service-organization with the adamant indifference of the overall welfare of the Department and its officials alongwith the unwarranted high-handed attitude of the Pr.DGIT(NADT), Nagpur is not acceptable to us and is condemned by the Central JCA in the strongest language.

The matter was taken up with the your goodself and the Member(P & V), CBDT, immediately on 13-06-2016 itself soliciting your kind intervention. Both of you were kind enough to agree to the fact that the ITGOA has every right to hold meeting in any office premises of the Department and

the NADT is not out of that. But unfortunately, despite the intervention of both of you, the Pr.DGIT(NADT), Nagpur refused to accord permission for holding the meeting inside the campus which tantamount to insubordination showing total disregard to the Institution she belongs.

The entire membership of JCA once again condemns the attitude of the Pr.DGIT(NADT), Nagpur and requests you to initiate appropriate action against the concerned officer failing which we will be constrained to launch agitational programme.
