Dear Comrades,

1. As it was intimated through the Circular No. 02, dated 03-03-2016, of the ITGOA and also the Circular of the JCA, dated 04-03-2016, that the members of JCA in all regions would observe protest against the inaction of the Department in presenting the anomalies detected in the 7<sup>th</sup> CPC Report to the appointed Committee of the GOI and the delay in promotion in the cadre of ACIT even after the sanction of the Hon'ble FM, GOI, etc. and would organise **Lunch Hour Demonstration on 09<sup>th</sup> March, 2016 in front of offices of all Pr.CCsIT.** It was also decided by the Central JCA, in its meeting on 02-03-2016 at New Delhi, to send a Resolution to the Revenue Secretary, GOI, and the Chairman, CBDT, from the Lunch Hour Demonstration, through the respective Pr.CCIT, **the copy of which is attached herewith**(the forwarding of the Resolution is to be made by the respective Units of JCA).

I also reiterate that it was decided, in the same meeting of the Central JCA, to collect Mass Signature from all members of the JCA which, along with the Resolution, will be sent to the Revenue Secretary, GOI, through proper channel within one month from 09-03-2016.

All the Units of ITGOA are requested to coordinate with the respective Circles of ITEF and make the Lunch Hour demonstration on 09-03-2016 a grand success.

- 2. It was also intimated through the Circular No. 02, dated 03-03-2016, of the ITGOA that the NJCA had given a call for Indefinite Strike action from 11-04-2016 against the retrograde recommendations of the 7<sup>th</sup> CPC. It is to inform that on the basis of a dialogue with the GOI, the NJCA has postponed the call for the Strike action.
- 3. The Committee for Amendment in the T & P Guidelines, 2010, held a meeting on 02-03-2016. Sri Aravind Trivedi, Addl. Secretary General attended the same on behalf of the ITGOA. The Committee had decided to meet again before finalising its recommendation and the next meeting of the Committee has been scheduled on 10-03-2015.

4. The Quarterly Review Meeting with the Chairman, CBDT, as demanded by the Central JCA, has been **scheduled on 17-03-2016** (the Notice of the meeting is attached herewith).

# RESOLUTION ADOPTED BY THE MEMBERS OF JOINT COUNCIL OF ACTION OF ----- UNIT IN THE LUNCH HOUR DEMONSTRATION HELD ON 09<sup>th</sup> of March, 2016

The Lunch Hour demonstration, at the call of the Central JCA, is organised by the JCA,Unit
on 09.03.2016 in front of O/o the Pr.CCIT() and resolves unanimously to appeal to The Chairman,
CBDT, New Delhi to take appropriate measure to resolve the following Demands.
Demands:
(i) To give effect to the promotions in the cadre of ACIT for 3(three) vacancy years within 31-03-2016.
(ii) To send strong recommendation to the Implementation Cell of the 7 <sup>th</sup> CPC to revise the pay of Income Tax
Officer, AO, PS, Inspector and Tax Assistant, as demanded by the JCA.
(iii) To ensure immediate Notification of pending RR of ITO/AO/PS/ITI/EA.
(iv) To re-allocate the posts of Inspectors to deficient charges (where stagnation is acute), as proposed by ITEF,
to remove such stagnation and to withdraw the order of Diversion of 1633 posts from West Bengal & Sikkim
Charge.
(v) To replace the old Laptops and to provide new Laptops to AO & PS and Inspectors. To provide Mobile
handset to all officials under the scheme of 1% Incentive for Infrastructure Development.
(VI) To improve the Infrastructural facilities in the Department, provision for ample space to the employees
with air-conditioning facility, provision for adequate residential accommodation according to the norms fixed
by CPWD.
(VII) To regularize the Casual Workers against the MTS posts sanctioned in the cadre restructuring.
(IX) To modify the existing RR of MTS. Recruitment of MTS to be done directly by the Department or through
the Employment Exchange as done by the Postal Department.
