



**ORDER No. 140 of 2015**



  - (i) Such appointment shall not confer any right to the offices for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DOP&T as contained in OM No. 28036/8/87-Estt.(D) dated 30.03.1988 and instructions issued by Government from time to time.
  - (ii) Outcome to the judgement of the Hon'ble Supreme Court in SLP (C) No. 21339/2012;
  - (iii) Will no confer any right or equity in favour of the appointees.
4. All the officers mentioned above should be relieved, wherever applicable, before 21<sup>st</sup> August, 2015 positively. The compliance report regarding relieving/joining of the above officers shall be forwarded by the concerned Pr. 
