(iii) The above promotions on ad-hoc basis shall not confer on the persons concerned any right to claim seniority in the grade of ITO or regular promotion as ITO.

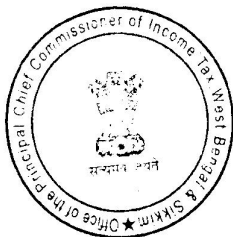
(iv) The above mentioned officers are not entitle to excecise the option in the matter of fixation of pay under FR 22(I)(a)(1). Such option can be given only on their regular promotion as ITO against regular vacancies.

(v) All the conditions prescribed in DOPT's instruction contained in OM No.28036/8/87-Estt(D) dated 30.03.1988, shall be applicable in case of above promotions.

(vi) The above Perons are liable to be reverted at any time without assigning any reason.

(a) On promotion, the Officers are posted as ITO(OSD) under the same CCIT/DGIT/PCIT/PDIT/CIT/DIT charge, where they were posted as Inspector prior to his promotion, with immediate effect and until further orders.

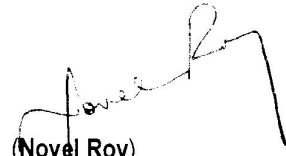
