**Sub :- AGT, 2018 in the cadre of Addl./JCIT – Board’s Order No. 102
of 2018 dated 03-07-2018 – regarding –**

With reference to the above-mentioned subject, we would like to invite your kind attention to our letter dated 5th March, 2018 in the matter of AGT 2018 in cadres of Addl./JCIT and DCIT/ACIT. We also requested you to ensure for no aberrations as regard the cooling off period as well as other parameters of the Transfer & Placement Guidelines, 2010. We had also enclosed list of officers who fulfilled their cooling off period & eligible for transfer as well as who falls under different eligible categories alongwith our said letter.

2. We appreciate you for considering our requests and ensuring less violation of Transfer & Placement Guidelines, 2010 in the AGT, 2018 order of DCIT/ACIT cadre. In our subsequent meetings it was assured to us the same will be followed in the cadre of Addl./JCIT also. You would appreciate that with the passing of such an order, the satisfaction level of the officers was very high and they have mostly joined their respective new assignments.

3. However, on perusal of the order No. 102 of 2018 dated 03-07-2018 in the cadre of Addl./JCIT, we find

- a) that while passing the order, focus has been placed mostly in respect of officers who have recently been promoted to the cadre of JCIT keeping the legitimate grounds of other officers almost unattended.
- b) that those officers who have completed the cooling off period as per para 4.8 of Transfer and Placement Guidelines, 2010, were earlier transferred out from their parent charges as per the Transfer and Placement Guidelines, 2010 but the Board did not consider their posting back to the parent region after completion of cooling off period, even after completion of 3(three) years in some cases.
- c) that apart from T & P guidelines, there are few physically challenged officers (both in ACIT/DCIT and JCIT/Addl.CIT cadres, covered under OM of the DoPT),also

some of the officers are in the zone of retirement and officers having other hardship whose cases were not considered.

As per Para No 4.8 of Group A transfer policy, officers are eligible for transfer to the parent region (region of their choice) after completion of 24 months i.e 2 years. The same was followed in the past AGTs and our members were expecting the same in this AGT order also. But since in this order no such case was considered even after completion of the requisite cooling off period, this order has caused total discontent and frustrations amongst the promotee Officers of the rank of Addl/JCIT.

4. This is total injustice meted out to the officers who have worked tirelessly with higher levels motivation towards achieving all targets fixed, especially crossing extraordinary collection of 10 lakh crores. We register our strong protest towards this gross injustice meted out to our members and we demand for immediate restoration of justice in this matter.


5. You will also appreciate that the officers of the level of Addl./JCIT, who are at JAG level, have a big role to play in achieving the Action Plan Target. The unfavourable consideration of their cases in the AGT, 2018 will demotivate them and which in turn may adversely affect in achieving the Action Plan Target particularly in the area of collection etc. Moreover, some of the officers are also in the zone of retirement and their cases deserve to be considered favourably to ensure that no injustice is done to them after rendering service in the department for so many years.

6. We would further draw your kind attention that we had requested to open the window for filing representation by the DCIT/ACIT who had grievances in regard to their transfer in the AGT, 2018. You had also assured us in the meeting held on 26-06-2018 that once the order in the cadre of Addl./JCIT is passed, the window will be opened. Since, huge grievances have arisen with the passing of recent order in the cadre of Addl/JCIT, we would request you to immediately open the window for filing representation by the officers in Addl/JCIT cadre too who have been denied justice by Board. In this connection, we are also enclosing list of Addl/JCIT who have completed cooling off period and those who are covered under the O.M of DoPT and also those who are in the zone of retirement for the perusal of the Board with a request to favourably consider all these cases.

7. In view of above, we would request you to kindly reconsider the cases not considered or left out in the AGT, 2018 for both Addl/JCIT and DCIT/ACIT cadres. A copy of the list submitted earlier is also enclosed for ready reference.


