ORDER NO. : 06/2017-18

In supersession of all earlier orders in this regard and in exercise of my powers conferred on me under Rule 13 of Delegation of Financial Power Rules, 1978, I, Principal Chief Commissioner of Income Tax, West Bengal and Sikkim, do hereby delegate the Administrative and Financial Power to the respective Chief Commissioner of Income Tax/Pr. Commissioner of Income Tax /Commissioner of Income Tax/Commissioner of Income Tax (Appeals), officiate at Aayakar Bhawan, Kolkata in respect of purchase and installation of new air conditioner machines in their respective offices. The maintenance of the said AC machines after the warranty period shall be looked after by the office of the Pr.CIT/CIT Building in-charge of Aayakar Bhawan.

While purchasing the new air conditioner machines, relevant Rules of GFR, 2017, DFPRs etc. shall be strictly followed. Every Chief Commissioner of Income Tax/Pr. Commissioner of Income Tax /Commissioner of Income Tax/Commissioner of Income Tax (Appeals) shall maintain a stock register of air conditioner machines and send a report for purchase and disposal to the office of the Pr. CCIT, WB & Sikkim as well to the office of the Pr. CIT/CIT Building in-charge as on 1st April of the respective years for further necessary action at their end.

The expenditure on account of purchase of new air conditioner machines shall be met out of the budgetary grants under the head "Office Expenses" allotted to the respective Pr. Commissioner of Income Tax /Commissioner of Income Tax/Commissioner of Income Tax (Appeals).

This order will take immediate effect and shall remain in force until further orders.


