Sub: Circulation of tentative list in the cadre of Income Tax Officer pertaining to panel/vacancy year 1994-95 to 2001-02, in the region of West Bengal & Sikkim—matter reg.

In view of the Hon'ble Apex Court Judgement in the case of Union of India & Ors vs N.R. Parmar & Ors (Civil Appeal No. 7514-7515 of 2005) dated 27.11.2012 and in perusance of the DoPT's O.M. No. 20011/1/2012-Estt.(D) dated 04.03.2014 read with the CBDT guidelines dated 29.09.2014, 07.11.2014 and 16.01.2015, the seniority list in the grade of Inspector of Income Tax have been revised from the year 1986-87 to till date. In view of such revision in the grade of Inspector of Income Tax, which constitutes the feeder grade for promotion to the grade of Income Tax Officer, the panels for promotion to the grade of Income Tax Officer drawn up in the past pertaining to panel/ vacancy year 1994-95 to 2001-02 have been revised by conducting review DPCs. On the basis of such revision, the **revised tentative seniority list** in the grade of **Income Tax Officer** pertaining to this region relevant to the **panel/ vacancy year 1994-95 to 2001-02** are hereby notified as per the approval of Principal Chief Commissioner of Income Tax, West Bengal and Sikkim. It may be mentioned that the relevant revised tentative seniority list pertaining to 1989-90 to 1993-94 in the cadre of ITO has already been notified vide this office notification dated 18.02.2016.

It may be stated that the cadre of Income Tax Officer is a 100 % promotional cadre and rota-quota method is not applicable in this cadre.

It may also be stated that no revision of seniority list in the grade of Income Tax Officer prior to the panel/ vacancy year 1989-90 is required for the following reasons.

- A. The list of the feeder grade (Income Tax Inspector) has been revised from 1986-87 onwards.
- B. Relevant recruitment rules prescribes three years residency period in the feeder grade as an eligibility condition for promotion as Income Tax Officer.

Objections, if any in connection with the above mentioned tentative seniority list may be submitted by the individual concern along with supporting documents/ evidences within three working days from the date of the publication of this circular.

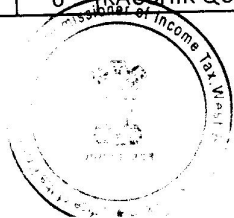
