Sub: Creation of dedicated set up for implementation of the prohibition of the Benami Property Transaction Act, 1988 (PBPT Act) as amended by Benami Transaction (Prohibition) Amendment Act, 2016.

In pursuance of the letter dated 5th April, 2017 of Central Board of Direct Taxes having F. No. 414/21/2017-IT(Inv.I), and in supersession of all earlier order, except as respects things done or omitted to be done before such suppression, the Principal Chief Commissioner of Income-tax, West Bengal and Sikkim hereby directs to create Benami Prohibition Unit (BPU), Kolkata as mentioned in column 3 of Schedule-'A' annexed hereto.
