- 2. The Directorate of Income Tax (Systems) has launched a new Email Solution for all Departmental employees. Old Lotus mail ids of domain @incometax.gov.in and IMail mail ids of domain @incometaxindia.gov.in have already been migrated to new Email Solution. The new Email Solution has retained the domain @incometax.gov.in.
- 3. The New Email Solution is accessible on intranet (TAXNET) as well as on internet through URL: https://webmail.incometax.gov.in. After launching the new mailing solution, the Directorate of Systems had issued designation based email ids to 7520 field users as per the new Jurisdiction order. The number of such email ids are based on the CIT(CO) region wise is given in Annexure A. The newly created designation based E-mail ids along with first password have already been communicated to respective CsIT(CO) office on their official E-mail ids (refer Annexure B for the list of official email IDs for CsIT (CO)). The entire list along with the default password is again sent to the CsIT (CO) for easy reference.
- 4. However, newly created E-mail ids are not being used actively by field users. Separately, the Directorate of Systems is receiving request from field users for creation of new Email ID. Apparently, users are unaware of the newly created post restructuring E-mail ids. In order to facilitate users / CsIT (CO), the entire list of email IDs, categorized CIT(CO) region wise is also placed on iTaxnet vide path Resources->Download->Systems->Instruction-ITBA->CIT(CO) region wise Designation based email ids.xlsx where users can check for their email ID. It may be noted that as per the latest Email policy of the Government of India, only the Departmental or Government email should be used for any official email communication.

- 5. The CsIT (CO) are requested to communicate the new E-mail id along with the password to field user on or before April 15, 2015. Field users can also get first/reset password directly by logging ticket in this regard on ITBA helpdesk and providing details like new E-mail id, Employee id, Tarang mobile number etc.
- 6. Due to the security policy, the reset password would be communicated only on official mobile number issued under project Tarang. In this regard, Directorate has requested respective Head Quarter office of the Pr CsCIT(CCA) to provide project Tarang details like Name, Employee ID, Designation, Posting, Mobile number etc. As of now, Directorate of Systems has received project Tarang details from 14 regions as per Annexure C. Tarang details would also help in building up HRMS data. Hence, for smooth functioning of Email Solution and HRMS module, the CsIT (CO) are requested to provide project Tarang details, if not provided earlier on or before April 15, 2015.
- 7. New E-mail ids are created in lieu of the old lotus E-mail ids which have also been migrated to the new mailing solution. However, the old lotus E-mail ids need to be discontinued. The CsIT (CO) are requested to provide the mapping of old lotus email ids with the new designation based E-mail ids, so that inbox (mails) can be migrated to the new E-mail ids before discontinuing the old lotus E-mail ids on or before April 15<sup>th</sup> 2015.

As a policy, the Old Imail or Lotus E-mail id lying unused for 6 months may be marked as dormant and would be deactivated immediately. If any new E-mail id is wrongly created, the same may be communicated to the Directorate of Systems for deletion/modification.

8. It is proposed that every officer up to the level of ITO would have a designation based email ID and also a name based email ID. The Designation based email ID would be used for all communication with taxpayers and for official communication that may need to be handed over to the succeeding incumbent in case of transfer etc. The designation based email ID would also enable viewing and response/forward by designated staff/ Hqrs. in case of Senior Officers. The name based email ID would be used / retained by the officer till retirement. In this regard, a data capturing screen has been deployed in ITD application for name based email id creation. This screen would capture details of an officer's request for name based email id creation and help in automating the process. Therefore, this facility may immediately be used by all officers and staff

accessing ITD system to obtain name based email ID. Thus, this screen would avoid paper form request as well as time delay for issuance of email ids.

- 9. It may be noted that a detailed list of proposed name based Email ID for senior officers (CIT and above) was circulated for confirmation by CsIT(CO) before allotment. However, there has been no response yet. In view of this the Directorate would proceed with the allotment of the proposed name based email ID on April 15<sup>th</sup> 2015.
- 10. To have a correct database of employees for HRMS, details from MMS and other modules have being reviewed. During this exercise various defects have been noticed:
  - i. Duplicate employee id
  - ii. invalid employee id (starts with '2')
- iii. Employee not having Employee ID

Therefore, the MMS data needs be corrected and it is reiterated that all employees must have a valid, non-duplicate employee ID. It is requested that this aspect may be given high priority. In this regard a consolidated list categorized region wise is placed on iTaxnet vide path Resources->Download->Systems->Instruction-ITBA->Region wise data to be corrected by CIT(CO).xlsx. The corrections may be carried out in MMS by April 15<sup>th</sup>, 2015
