
Subject: Constitution of a Task Force to oversee implementation of the Hon'ble Supreme Court Judgement dated 27.11.2012 in the case of N. R. Parmar and Others Vs. Union of India and Others in all zones of Income Tax Department w.r.t. promotion from ITO to ACIT- regarding.

In accordance with the approval of The Competent Authority, it has been decided to constitute a Task Force under the Chairmanship of Joint Secretary (Admn.) CBDT, to implement the judgment of N.R. Parmar case by conducting Review DPCs after recasting the All India Seniority List of ITOs for promotion to the grade of ACsIT for various Vacancy Years.

2. The Terms of Reference of Task force will be as under:

(a)	To study and identify the bottlenecks in zones where timely DPCs could not be conducted in the light of judgment of N.R. Parmar.
(b)	Assign responsibility to respective DCITs/JCITs for initiating steps to recast seniority in accordance with guidelines of Government of India after disposing of representations from stakeholders.
(c)	Monitoring the work for conducting Review DPCs of ITIs/ ITOs in each zone and ensuring completion within two months in all respect. Also direct the concerned CCsIT to prepare seniority lists in a time bound manner for further action.



3. The Task Force will submit its report to the 'Board' within 3 months from date of the order.

4. All the Cadre Controlling Authorities of respective 18 zones, including office of DGIT (HRD) & office of PR, PP & OL are requested to provide their inputs/views on Terms of References so that same can be examined by the Task Force before finalizing its recommendations.

5. The members of the Task Force will be visiting respective zones in order to address immediate issues arising out of discussions to ensure timely implementation of the Hon'ble Apex Court Judgment for the purposes of coordination and inter-zonal consultation, if so required.
