- 2. The monthly rent for hiring the vehicle should not exceed the ceiling as prescribed by the CBDT.
- 3. The expenditure on account of hiring the vehicle shall be met out of the budgetary grant under the head "Office Expenses".
- The vehicle may kindly be hired for such purposes from the existing or new vendors after observing the prescribed procedure as per GFR 2005.
 - While hiring the vehicle, it may kindly be ensured that: 5.
 - (i) The reputation of the vendors with their past performances should be taken into account before the contract is signed with them.
- (ii) The vehicle should conform to the latest BS (Bharat Stage) Emission norms.
 - (iii) The hired vehicle should not be more than 2(two) years old.

(iv)All the hired vehicles must have commercial registration number (yellow no. plate), as per the written direction of the Public Vehicles Department of Government of West Bengal.

The order takes immediate effect.
