To The Chairman, Central Board of Direct Taxes, North Block, New Delhi.

Respected Sir,

Sub: Extension of last date of joining for the officers transferred vide AGT orders no. 55 & 56 of 2017- request reg.

Kindly refer to the above.

We have already submitted a letter on 27.04.2017 requesting you to kindly extend the last date of joining for the ACsIT, who have been transferred out of their current region vide the order no. 55 of 2017 and at the same time nominated for Orientation Course at NADT, Nagpur, to be commenced on 15.05.2017, up to a suitable date after the completion of the training programme on 12.07.2017. It is pertinent to mention that the Pr. CCsIT (CCA) have been nominating only those officers for Orientation Course at NADT, Nagpur who have been retained in their charges by the AGT order and all transferred out officers, as they are yet to join in their new charges are not being nominated for the training program by either the transferor or the transferee Pr. CCsIT. It may lead to inconvenience and unwarranted complicacy for all these officers to attend the Orientation Course and also for the NADT, Nagpur authority for organising the Course.

Also, the online window for filing the representation against the AGT-2017 Orders in the grades of AddI.CIT/Jt.CIT & DCIT/ACIT has been opened on 27.04.2017 itself and all those officers, who want to submit their application/representation against the AGT -2017 transfer orders, have been asked to do the same by 07.05.2017 while the Pr. CCsIT (CCA) have been asked to send compliance report by 05.05.2017 in respect of both the AGT orders.

Sir, you will appreciate that the cases, where agreed upon T&P Guidelines have been violated or education, medical, spouse or compassionate grounds have been overlooked or options exercised have been ignored etc., will definitely be considered in favour of the affected officers. In those cases, the officers will have to join in a new region by 05.05.2017, only to find the previous transfer order stayed or cancelled or amended just within a few days.

In view of the above, it is humbly requested that considering the convenience of both the administration and the affected officers as well as the financial implication involved, the Corrigendum orders may kindly be passed soon after the closing of representation window on 07.05.2017 and the last date of joining or sending of compliance report for all the officers covered under Order No. 55 & 56 of 2017 may be extended suitably.
