At the outset, Sri Mrinal Chanda, President apprised the members, present in the meeting, the reason for calling of this emergency meeting due to non holding of the DPC scheduled to be held on 18.1.2012 for promotion of ITOs to ACIT as a result of Supreme Court decision in Parmar's Case.

B.Bhattacharya: DPC of 18.12.2012 was withheld indefinitely due to the strange reason that a letter was forwarded by CCIT, Gujrat to the CBDT based on the decision of Supreme Court in N.R. Parmar. A committee had been constituted by CCIT, Gujrat who drafted a letter and the same was sent to Board. The Board in turn referred the matter to MOL for its opinion. As such the meeting of the DPC was not held on 18.12.12. It is learnt that the Secretary General made an attempt to meet the Member(P), CBDT. However, no positive response could be received from the Member(P).

It appears that the whole exercise was to delay the DPC by at least 12 days so that the promotion can be equated with direct recruits. Already Bihar Unit has held a meeting and demanded EOGM.

Member(Inv) visited M.P. where black flag demonstration was held. Some action should be initiated to make the Board to conduct the DPC within 31st Dec. 2012. Further, West Bengal unit should also demand immediate holding of EOGM of ITGOA.

President requested the members to give their opinion in order to decide next course of action.

Sumit Dasgupta : What is the contents of the CCIT, Ahmedabad's letter.

Sri B.Bhattacharya: Many inspectors have demanded that date of notifications be considered instead of date of joining. Then many more ITOs may come into the consideration zone of the DPC for R.Y. 2012. As such unless this issue is resolved, the DPC may not be held.

Sri Sanjoy Mukherjee: The Secretary General has not been entertained by the member. Hence the views of the officers have not been properly represented before the Board. Accordingly, a letter may be sent from all the officers to the chairman to draw his attention. The decision of the Supreme Court unless endorsed by the DOPT cannot be worked upon. Hence the Board may be asked to retract the letter to MOL. We should ask Shri Rajesh Menon to immediately take up the matter with CBDT. Let us take a strong resolution and send it to the CHQ as has already been done by Bihar Unit.

Sri Subrata Dhar: I had spoken with Rajesh Menon on phone. He said that the matter will take time of minimum up to 15th or 18th January,2013. It shows that he has no intention to move the matter quickly. There is a discussion regarding giving Ad-hoc promotion but same shold be avoided.

Sri Sumit Dasgupta: Let us not oppose the ad-hoc promotion.

Sri Avijit Ghosh: We can do the following:

- 1) Force to Board to do something about the matter.
- 2) This can be done only through CHQ
- 3) To activate the other units.

Sri Sanjoy Panday:

- 1. Single issue for promotion to be demanded.
- 2. 143 promotion to be given in Dec.
- 3. 295 regularized by January, 2013
- 4. Other by March, 2013.

We should immediately make the following demands before the Board.

- 1) We can ask for filling up the vacancies arising out of cascading effect of regularization of adhoc promotion of JCIT which will result in about 500 promotion.
- 2) But there may be problem in giving promotion as we do not have proper seniority list.
- 3) Ask the Board to give effect on a time barred manner, like the way we have to complete our time barred jobs. If the Board does not respond to this demand we may also stop doing work other than the time barred jobs.

But whatever we do, we will have to do this within 12 days. Hence all the other units should be united and agitational call should be given to attract the attention of the F.M.

We may consider giving some public statement.

President requested Sri Sanjoy Pandey to read out the draft letter proposed to be sent to the Secretary General on the issue and Shri Pandey read out the draft letter.

Sri B.Bhattacharya: We can pressurize the CHQ in this matter by adopting a strong resolution in this meeting for starting immediate agitational programme to force the Board to hold the DPC within Dec. 2012 and also to convene an EOGM of ITGOA. Copy of the letter may also be forwarded to all state units with a request to demand for convening the EOGM.

After detailed discussion members present in the meeting approved the draft letter.

Sri **B.Bhattacharya** suggested for stopping the work relating to ASK, Demand Management and all other work which the Board considers to be priority area of work excepting the time barred work,

President informed the house that a letter, addressed to the Chairman, CBDT has also been drafted and all the members of West Bengal Unit should send the same to CBDT. Monalisa Pal Mukherjee read out the draft letter and the members present in the meeting approved the same. It has been decided that all members will send the letter to the Chairperson by E-mail.

It was further decided that all members will send a SMS to Secretary General (Ph.Nos.09013851915 & 09869504653) conveying their deep concern about the turn of events and asking him to initiate some strong measure so that immediate DPC is held without any delay..

The meeting ended with thanks to the chair.
