

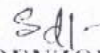

NOTIFICATION No. 02

In pursuance of the notification of the Central Board of Direct Taxes in S.O.2752 (F) [Notification No. 50/2014/F.No.187/38/2014(ITA.I) dated 22nd October, 2014 and Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi communication from F.No.HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and subsequent Corrigendum from F.No. HRD/CM/102/28/2013-14/4488 dated 17th October, 2014 and in supersession of all earlier orders on the subject, except as respects things done or omitted to be done before such supersession, the Principal Chief Commissioner, West Bengal and Sikkim hereby directs creation of Ranges headed by Addl. Commissioners / Addl. Directors of Income-tax / Joint Commissioners / Joint Directors of Income-tax specified in the column (4) of the Schedule annexed hereto having his / her headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule.
2. The Ranges headed by Additional Commissioners / Additional Directors of Income-tax / Joint Commissioners / Joint Directors of Income-tax, so created, is out of the posts of Additional Commissioners / Additional Directors of Income-tax / Joint Commissioners / Joint Directors of Income-tax temporarily allocated to the West Bengal and Sikkim Region under Cadre Restructuring Scheme, 2013 of the Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi communication from F.No.HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and shall function under the administrative control of the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule **till such date any order/instruction are received from CBDT in matter of temporary allocation of posts.**
3. Consequent to this Notification, the designated post "Additional Commissioners / Additional Directors of Income-tax / Joint Commissioners / Joint Directors of Income-tax appearing in schedules to the relevant Notifications dated 15.11.2014 by this office regarding abolition and creation of posts read with necessary corrigenda are re-designated as per Schedule-B annexed to this Notification dated 21.06.2016. The Notifications dated 15.11.2014 are amended to that extent.
4. This order shall come into force with immediate effect.

In pursuance of the notification of the Central Board of Direct Taxes in S.O.2752 (E) [Notification No. 50/2014/F.No.187/38/2014(ITA.I) dated 22nd October, 2014 and Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi communication from F.No.HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and subsequent Corrigendum from F.No. HRD/CM/102/28/2013-14/4488 dated 17th October, 2014 and in supersession of all earlier orders on the subject, except as respects things done or omitted to be done before such supersession, the Principal Chief Commissioner, West Bengal and Sikkim hereby directs creation of Circles headed by Deputy Commissioners / Deputy Directors of Income-tax / Assistant Commissioners / Assistant Directors of Income-tax specified in the column (5) of the Schedule annexed hereto having his / her headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (4) of the said Schedule.

The Circle headed by Deputy Commissioners / Deputy Directors of Income-tax / Assistant Commissioners / Assistant Directors of Income-tax, so created, is out of the posts of Deputy Commissioners / Deputy Directors of Income-tax / Assistant Commissioners / Assistant Directors of Income-tax temporarily allocated to the West Bengal and Sikkim Region under Cadre Restructuring Scheme, 2013 of the Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi communication from F.No.HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and shall function under the administrative control of the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule **till such date any order/instruction are received from CBDT in matter of temporary allocation of posts.**
