 - The Adhoc promotion shall not confer on the official concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;
 - The official is liable to be reverted at any time without assigning any reason,
 - The promotion is valid for one year or till his reversion to the feeder cadre or regularisation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.
 - The official is not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. He will be entitled to exercise the option on the regularization against regular vacancy.
- The promotion of the above official is based on revised seniority list published after giving effect to the decision of N.R.Parmar and Ors. 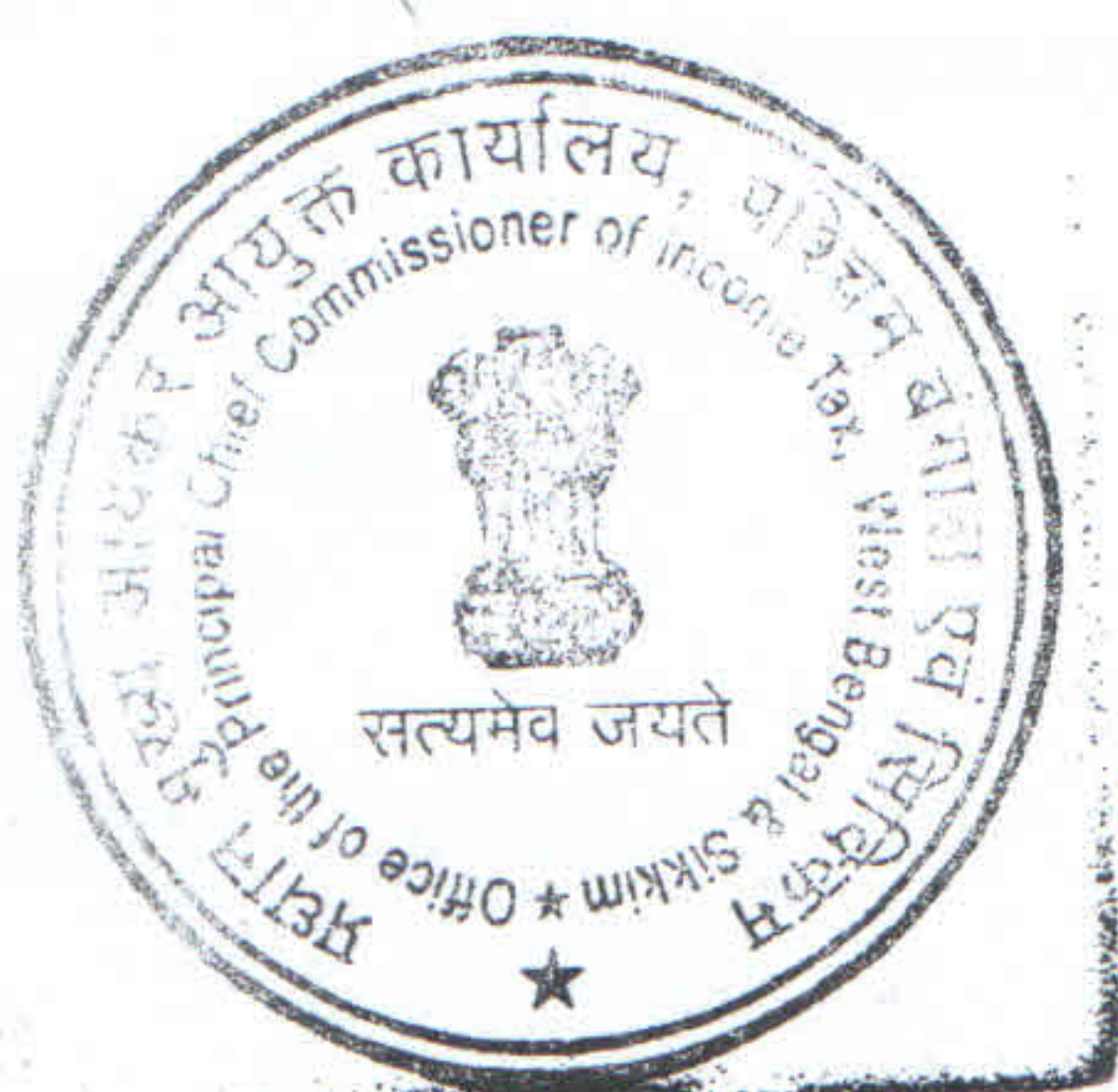
