**Sub: Circulation of draft All India *inter-se* seniority list of Administrative Officers Grade-II in terms of Department of Personnel & Training's O.M. dated 04.03.2014 -reg.**

Sir/Madam,

I am directed to refer to the above mentioned subject and to say that a draft All India *inter-se* seniority list of Administrative Officers Grade-II (AO Gr. II) (from V.Y. 2013-14 to 2021) has been prepared on the basis of regional Seniority list of A. O. Gr.II as provided by the CCAs concerned, in terms of DoP&T's O.M. dated 04.03.2014.

2. The Pr. CCIT, West Bengal & Sikkim has not provided their regional seniority list of A.O. Gr II in terms of DoP&T's O.M. dated 04.03.2014 till date. Whereas all other regions/CCAs have provided their regional seniority list of A.O., Gr. II after prospective implementation of N.R. Parmar judgment in terms of DoP&T's O.M. dated 04.03.2014. Therefore, the names provided by the O/o Pr. CCIT, West Bengal & Sikkim have not been interpolated with other regions & have been placed en-bloc below the last person in the draft AIISL of A.O. Gr. II from S.No. 346 to 359. Their Seniority shall remain provisional & shall be fixed at appropriate place once the regional seniority list in terms of DoP&T's O.M. dated 04.03.2014 is provided to the Board.

3. The respective CCA is requested to circulate the draft AIISL of A.O. Gr.-II amongst the concerned officers & forward their representation(s), if any, to the Board alongwith the specific recommendation of the Pr. CCIT concerned, **by 15.12.2021, failing which the draft seniority list will be finalized.** The respective CCA is also requested to verify the information/data provided against the officers in their region from the record and report discrepancy, if any, to the Board by the stipulated date alongwith supporting document(s). The O/o Pr. CCIT, Mumbai, Pune & Nagpur are also requested to ensure that the data/information i.r.o. blank columns against the respective officers in their region are also provided to the Board by the stipulated date.
