- 2. The tenure of posting under the 'Scheme' shall be for a period of 3 years (extendable up to 5 years) starting from the date of this order or the date of joining the DIT (CPC- ITR) in compliance to this order whichever is later.
- 3. The Officers/officials would continue to work in the DIT(CPC-ITR), Bengaluru till further orders as per clause (b) of 'Scheme' on temporary diversion of post from their cadre controlling authorities, hereinafter, called the 'Home Region' to Pr. CCIT under whose territorial jurisdiction the office/subordinate office of DIT(Systems) i.e., DIT(CPC-ITR), Bengaluru is situated. As a result, while performing duties in Directorate of Systems, they will continue to hold their cadre post and will not suffer loss of seniority in their respective home region. Since the Officers/ Officials at Sl. No. 1-10, 12 & 17 above are already in the cadre strength of Pr. CCIT, Karnataka & Goa, this diversion will be applicable only for those officers/ officials who are getting posted to DIT(CPC-ITR), Bengaluru from outside the Karnataka & Goa region (Sl. No. 11, 13, 14, 15 & 18).
- 4. In case the officer/ official concerned is promoted, such officer/ official shall, barring exceptional circumstances, continue to be posted at DIT (CPC-ITR), Bengaluru until his/ her normal tenure as per clause (a) of the Scheme has expired.
- 5. On repatriation on completion of their stay at the DIT(CPC-ITR), Bengaluru or otherwise in accordance with 'Scheme' and as approved by Competent Authority, the post along with the officer/official would revert back to their 'Home Region'.
- 6. The officers /officials would be eligible to draw their pay and allowances from DIT(CPC-ITR), Bengaluru.
- 7. All other provisions of the 'Scheme' dated 15.04.2019 shall apply.
- 8. The compliance reports regarding relieving of the abovesaid officers/ officials shall be forwarded by the Pr. CCIT (CCA) concerned to the Board and Data Base Cell, CBDT by 25.08.2023.
